#### FIRST AMENDMENT TO SUPPORT FACILITIES LEASE AGREEMENT

THIS FIRST AMENDMENT TO THE SUPPORT FACILITIES LEASE AGREEMENT is made and entered into as of the date stated on the City's signature page below, by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado, on behalf of its Department of Aviation ("the City") and SWISSPORT CARGO SERVICES, LP, a corporation organized and existing under and by virtue of the laws of the State of California and authorized to do business in the State of Colorado ("Tenant").

#### WITNESSETH

WHEREAS, the City owns and operates Denver International Airport ("DEN" or the "Airport"); and

WHEREAS, the parties hereto entered into a certain Support Facilities Lease Agreement, which was effective November 9, 2020, contract number 202055043-00, (the "Existing Agreement"), under which the Tenant and the City agree to the terms of the Tenant's use and lease of certain Demised Premises and facilities at the Airport; and

**WHEREAS**, the City is using a new contract management software system, and as a result, the contract number for this Agreement is being changed from 202055043-01 to 202158439-01;

**WHEREAS**, the parties now wish to amend the Existing Agreement so that Tenant may lease additional space from the City to support its operations at the Airport; and

**NOW, THEREFORE,** for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

- 1. Exhibit A Demised Premises to the Existing Agreement shall be deleted in its entirety and replaced with the new Exhibit A Demised Premises, attached hereto.
- 2. Section 4.01 of the Existing Lease is deleted and replaced with the following new Section 4.01:

#### **Section 4.01 TERM OF LEASE**

"The term of this Lease shall commence on the Effective Date and shall terminate on December 31, 2022, unless this Lease is earlier canceled or terminated as hereinafter provided."

- 2. Except as modified by this Amendment, all of the terms and conditions of the Existing Agreement shall remain in full force and effect.
- 3. This Amendment shall not be effective or binding on the City until approved and fully executed by all signatories of the City and County of Denver.
