### REVIVAL AND THIRD AMENDATORY AGREEMENT

This **REVIVAL AND THIRD AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City"), and **COLORADO NONPROFIT DEVELOPMENT CENTER**, a Colorado nonprofit corporation whose address is 789 Sherman St., Suite 250, Denver, CO 80203 (the "Contractor"), jointly ("the Parties").

### **RECITALS:**

- **A.** The Parties entered into an Agreement dated June 10, 2020, an Amendatory Agreement dated October 26, 2020, and a Second Amendatory Agreement dated November 20, 2020 (collectively, the "Agreement").
- **B.** The parties wish to revive and reinstate all of the terms and conditions of the Agreement, and amend the Agreement to amend the Scope of Service, extend the Term, and decrease the Maximum Contract Amount.

**NOW THEREFORE**, in consideration of the premises and the Parties' mutual covenants and obligations, the Parties agree as follows:

- 1. The Scope of Services attached as **Exhibit A-2** to the Agreement is deleted and the Scope of Services marked as **Exhibit A-3** attached hereto is incorporated herein by this reference. All references to "**Exhibit A-2**" in the Agreement shall be amended to read: "**Exhibit A-3**".
- 2. The Budget attached as **Exhibit B-2** to the Agreement is deleted and the Budget marked as **Exhibit B-3** attached hereto is incorporated herein by this reference. All references to "**Exhibit B-2**" in the Agreement shall be amended to read: "**Exhibit B-3**".
- 3. The Certificate of Insurance attached as **Exhibit** C to the Agreement is deleted and the Certificate of Insurance marked as **Exhibit** C-3 attached hereto is incorporated herein by this reference. All references to "**Exhibit** C" in the Agreement shall be amended to read: "**Exhibit** C-3".
  - 4. Section 3 of the Agreement, entitled "**TERM**:", is amended to read as follows:
    - "3. <u>TERM</u>: This Agreement will commence on June 1, 2020, and will expire on December 31, 2021 (the "Term"). Subject to the Executive Director's prior written authorization, the Contractor shall complete any work in progress as of the expiration date and the Term of this Agreement will extend until the work is completed or earlier terminated by the Executive Director."

- 5. In Section 4(d) of the Agreement, entitled "Maximum Contract Amount:", Subsection (1) is amended to read as follows:
  - "(1) Notwithstanding any other provision of this Agreement, the City's maximum payment obligation will not exceed **THREE MILLION EIGHT HUNDRED FORTY-NINE THOUSAND NINE HUNDRED SEVENTY-SEVEN DOLLARS AND NO CENTS (\$3,849,977.00)** (the "Maximum Contract Amount"). The City is not obligated to execute an Agreement or any amendments for any further services, including any services performed by the Contractor beyond that specifically described in Exhibit A-3. Any services performed beyond those in Exhibit A-3 are performed at the Contractor's risk and without authorization under this Agreement."
- 6. Section 7 of the Agreement, entitled "**EXAMINATION OF RECORDS AND AUDITS:**", is amended to read as follows:
  - "**7**. **EXAMINATION OF RECORDS AND AUDITS:** The Contractor shall maintain records of the documentation supporting the use of CRF Funds in an auditable format, for the later of five (5) years after final payment on this Agreement or the expiration of the applicable statute of limitations. Any authorized agent of the City, including the City Auditor or his or her representative, and for CRF Funds any authorized agent of the Federal government, including the Special Inspector General for Pandemic Recovery ("Inspector General") have the right to access, and the right to examine, copy and retain copies, at the official's election in paper or electronic form, any pertinent books, documents, papers and records related to the Contractor's use of CRF Funds pursuant to this Agreement. The Contractor shall cooperate with Federal and City representatives and such representatives shall be granted access to the foregoing documents and information during reasonable business hours and until the latter of five (5) years after the final payment under the Agreement or expiration of the applicable statute of limitations. When conducting an audit of the use of CRF Funds, the City Auditor shall be subject to government auditing standards issued by the United States Government Accountability Office by the Comptroller General of the United States, including with respect to disclosure of information acquired during the course of an audit. No examination of records and audits pursuant to this section shall require the Contractor to make disclosures in violation of state or federal privacy laws. The Contractor shall at all times comply with D.R.M.C. 20-276."
- 7. As herein amended, the Agreement is revived, affirmed, and ratified in each and every particular.
- 8. This Revival and Third Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.

\*\*It is anticipated that grant amounts would be available in three (3) increments of \$633,333 per round in advance of the distribution.
