

LIMITED DELEGATION OF AUTHORITY TO ENFORCE SPECIFIC ORDINANCES OF THE CITY AND COUNTY OF DENVER

Pursuant to the power vested in the Executive Director of the Department of Public Safety by Section 2.6.3 of the Charter of the City and County of Denver ("Denver") and subject to the Specifications of Authority hereinafter described, qualified and commissioned members of the Denver Street Enforcement Team ("SET") are hereby authorized to enforce specific Denver municipal ordinances as detailed herein.

SPECIFICATION OF AUTHORITY

Commissioned members of the Denver Street Enforcement Team are hereby authorized and empowered to enforce specific provisions of the Denver Revised Municipal Code (DRMC), only in the manner specified as follows:

- Commissioned members of the Denver Street Enforcement Team are hereby authorized and empowered to issue citations for violations of the following sections of the DRMC:
 - a. 38-31(c) Failure to obey a lawful order
 - b. 38-40 False information
 - c. 38-43 Violation of court orders
 - d. 38-61 Destruction of public property
 - e. 38-71 Destruction of private Property
 - f. 38-86 Obstruction of streets or other public passageways
 - g. 38-86.2 Unauthorized camping
 - h. 38-99 Urinating or defecating in public
 - i. 38-102 Possession of graffiti materials prohibited
 - j. 38-115 Trespass
 - k. 39-1(b) Violation of park rules & regulations
 - I. 39-3 Park curfews and closures
 - m. 39-6 Destruction of park property
 - n. 38-175 Possession or consumption of marijuana
 - o. 48-44 Illegal dumping
 - p. 49-553 Littering
 - q. 54-415 through 54-518 Parking
 - r. 54-612 through 54-624 Electric scooters
 - s. 57-24 Damaging trees on public property
 - t. 57-26 Unauthorized use of trees on public property
- 2. This delegation of authority confers *only* the power to issue citations for these violations of the DRMC and does *not* grant the power to arrest for these or any other law violations.

Before exercising authority under this delegation, each member of the Street Enforcement Team must be individually and specifically commissioned, and such commission shall be granted only after the SET member has completed a mandatory training program from the Denver City Attorney's Office, the Department of Safety, and the Department of Housing Stability.

It is understood that the commissions granted pursuant to this delegation of authority expire when employment requiring appointment terminates, and exist at the pleasure of the Executive Director of the Department of Public Safety, who reserves the right in his/her sole discretion to revoke said commissions if he/she feels that revocation serves the best interests of Denver or the general public.

This delegation of authority is effective immediately and will continue for six months, expiring on December 31, 2021, unless extended, rescinded, superseded, or amended in writing by the Executive Director of the Denver Department of Safety.
