5. General description or background of proposed request. Attach executive summary if more space needed:

Reimburses DHS for costs for placement and supportive services for Unaccompanied Refugee Minor (URM) youth placed into the custody of DHS. The URM program ensures that eligible unaccompanied minor populations receive the full range of assistance, care and services available to all foster children in the state by establishing a legal authority for DHS to act in place of the child's unavailable parent(s). The URM program encourages reunification of children with their parents or other appropriate adult relatives through family tracing and coordination with local refugee resettlement agencies. However, if reunification is not possible, the program works to design a case-specific "permanency plan" for each minor or youth in care. A permanency plan is the "long-term" plan for where a child will live, along with the development of what would hopefully become long term relationships, to help each child transition into adulthood. Through its network of providers, URM assists client youth to develop appropriate skills to enter adulthood and achieve social self-sufficiency. URM youth can remain in the care and custody of Denver Human Services until age 21, at which point, they emancipate from the foster care system.

DHS agrees to participate in URM monthly meetings, annual URM trainings, and other reasonable requests for the purpose of maintaining current on rules and practices related specifically to serving URM eligible populations.
