**A BILL**

**For an ordinance making a rescission from and an appropriation in the General Fund.**

**WHEREAS**, the City desires to make a payment to the National Western Center Authority to fund capacity building and provide technical assistance to the Globeville Elyria Swansea community to stand up processes for the Community Investment fund Committee, NWC Phases 3-8 Development and a Community Benefits Agreement;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**
