EXECUTIVE SUMMARY

The purpose of the resolution is to set a public hearing to approve the First Amended and Restated Service Plans for West Globeville Metropolitan District No. 1 and West Globeville Metropolitan District No. 2 located on the Fox Park site.

The purpose of the metro districts are to finance, construct, own, and maintain public improvements supporting land uses containing retail, commercial, and multifamily residential.

State law requires notice of a public hearing on the First Amended and Restated Service Plans be at least 20 days prior to a public hearing which will be at City Council on November 29th. A presentation in Finance and Governance Committee is anticipated to be scheduled on November 9th.

The ordinance requesting to approve the First Amended and Restated Service Plans will promptly follow this resolution and staff will be asking for the resolution to pass out of committee on consent since the presentation will be conducted as part of the ordinance approving the First Amended and Restated Service Plans.
