5. General description or background of proposed request. Attach executive summary if more space needed:

Ninth Amendment to Intergovernmental Agreement (IGA) for the Denver Fire Department to provide fire protection services within the municipal boundary of the City of Sheridan (including specific fire prevention services-plan reviews, fire safety inspections, etc.). Revenue amount for 2022 will be \$188,573.93 per month. In 2010, the City and County of Denver entered into an agreement with the City of Sheridan to provide fire suppression services for its citizens. The initial IGA was approximately a 2-year period (9/15/10-12/31/12). Beginning with the Second Amended and Restated Agreement, City of Sheridan officials requested for the review and renewal of the IGA on an annual basis.

The Denver Fire Department provides fire suppression, emergency medical services, technical rescue, hazardous materials response, water and high angle rescue to residents of the City and County of Denver. These fire and emergency services are also provided to City of Glendale, City of Sheridan, Englewood and Skyline Fire District through separate intergovernmental agreements.

Combining and adding Fire Station lease FIRES-201208810 into this one contract. Denver Fire's Engine 36 operates out of Sheridan's old Fire Station located at 4101 S. Federal Blvd which is owed by Sheridan. This lease agreement with an annual rent of \$1 was formally executed as a separate, concurrent agreement to the IGA to provide fire protection services to Sheridan. Combining this into one contract will simplify the administrative renewal process.
