6 **For an ordinance establishing a new Fund in the Community Development**
7 **Special Revenue Fund Series for the “HOST Performance Contracts”**
8 **program.**

10 **WHEREAS**, since 2015, the Department of Finance has administered the Social Impact
11 Program, which leverages performance-based contracts to support initiatives aimed at measurably
12 improving the lives of people most in need by driving resources towards better, more effective
13 programs; and

14 **WHEREAS**, starting in 2022, the Department of Housing Stability will administer these pay
15 for performance programs, which provide housing and supportive case management services to
16 homeless individuals who frequently use the City’s emergency services, including police, jail, the
17 courts, and emergency rooms; and

18 **WHEREAS**, the 2022 Budget includes an appropriation for the “HOST Performance
19 Contracts” program which requires a new Fund to administer transactions related to said program;

21 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
22 **OF DENVER:**

24 **Section 1.** A new Fund is hereby established in the Community Development Special Revenue
25 Fund Series, Accounting No. 16000, a “HOST Performance Contracts” Fund, Accounting No. 16814,
26 for the purpose of accounting for the receipt and expenditure of program dollars.

27 **Section 2.** Monies received from General Fund transfers, transfers from the current Social
28 Impact Program Fund, Accounting No. 11863, and other sources of income for Accounting No.
29 16814 shall be deposited into the Treasury of the City and credited to Special Revenue Fund No.
30 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City
31 and County of Denver.

32 **Section 3.** Program expenditures are hereby authorized for the “HOST Performance Contracts”
33 Fund, Accounting No. 16814, to be expended by the Executive Director of the Department of

1 Housing Stability. Allowable expenses will include performance-based payments to contractors
2 providing programming including but not limited to housing and supportive case management
3 services to homeless individuals who frequently use the City's emergency services, including police,
4 jail, the courts, and emergency rooms. The Chief Financial Officer may transfer unused balances in
5 the Fund to the General Fund. This Fund is appropriated and non-lapsing.

6 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
7 and directed to make such book and record entries and to do such other things as may be necessary
8 to accomplish the purposes of this Ordinance.
