18	Section 1. A new Fund is hereby establi	shed in the General Government Special Revenue		
19	Fund Series, Accounting No. 11000, a "Redaction Services" Fund, Accounting No. 11883, for the			
20	purpose of accounting for the receipt and expenditure of program dollars.			
21	Section 2. Monies received from Genera	Fund transfers for Accounting No. 11883 shall be		
22	deposited into the Treasury of the City and credited to Special Revenue Fund No. 11000, which is			
23	set forth and described in Section 20-18 of the	Revised Municipal Code of the City and County of		
24	Denver.			

Section 3. Program expenditures are hereby authorized for the "Redaction Services" Fund, Accounting No. 11883, to be expended by the Clerk and Recorder. Allowable expenses include costs to redact online records and images containing certain personally identifiable information in accordance with state statutes. The Chief Financial Officer may transfer unused balances in the Fund to the General Fund. This Fund is revenue-based and non-lapsing.

Section 4. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary

to accomplish the purposes of this Ordinance.
