the 2021 Fiscal Year is hereby appropriated for such purpose.

6 Section 3. That imposition of Capital Charges which are necessary for the purpose of the 7 District's expenses as set forth in the 2022 Work Plan and Budget, are hereby approved. 15 **Section 5**. That the fiscal year of the District shall begin on the first day of January and end 16 on the last day of December each year.
