Current threshold is measures by a dilution threshold (7:1) or 5 or complaint driven.

The proposed ordinance also includes targeted industries and will be driven by complaints.

Flynn asked about the affirmative defense approach to the odor control plans and an affirmative defense against complaints - What remedies would be available?

Fines are up to \$3,000 per day.
