The City and County of Denver DOTI Bridge Group is seeking to amend this on-call contract adding two years and two million dollars to provide bridge and structural construction services on an on-call, as-needed basis for various City projects.

Through a competitive RFQ procurement ABCO Contracting, Inc., shall be awarded an on-call, as needed service contract with the City and County of Denver, for performing citywide bridge and structural construction services.
