- To apply savings from Decker Branch payment to Denver Health for the Public Health Clinics.

The transfer to the Planned Capital Equipment and the Elections Equipment SRFs for the following

- Denver Fire Department replacement capital equipment purchases for fire and response including gas detectors, calibration equipment, and tablets.
- Denver Public Library capital equipment purchase of two sets of lockers in Library local service area to allow customers 24/7 access to retrieve materials placed on hold.
- Denver Public Library purchase of a video wall for the Decker Branch Library in RINO
- A capital equipment purchase of a Ballot Sorter Machine for the Clerk and Recorder's Office
