AMENDS legacy contract MOEAI- 202263625 with Summer Scholars to add \$525,00 for a new contract amount of \$875,700 and 27 months for a new end date of 8/31/2026 to provide comprehensive out of school time programs to 500 Denver youth, in grades kindergarten through 5th, at 3 sites during the school year and summer programs. All programs are provided to families at no cost. The definition of comprehensive programming is 12+ hours per week for 32 weeks during the school year and 30+ hours per week for 6+ weeks during the summer.
