This ordinance request seeks approval to establish a new non-lapsing “Colorado Convention Center” capital special revenue fund (Fund 38422). The source of revenue to this fund will be Facilities Development Admission (a/k/a Seat Tax) generated annually at the Colorado Convention Center (CCC), CCC hotel excess revenue, the proposed Tourism Improvement District’s (TID) share of the future CCC COP (pending approval the future COP by City Council), as well as the 2C funding dedicated to capital maintenance at the CCC (\$1M annually growing to \$5M annually in 2024). Future COP debt payments, required debt reserves, and capital improvements for the CCC will be appropriated in this fund. Appropriations will be made via the annual budget process.
