**Type and Scope of services to be performed:**

Sun Valley Gateway North will be a newly-constructed multifamily rental property located in Sun Valley. The property will provide 95 units of family housing, with 43 units covered by project-based Section 8 vouchers. The city's loan of \$2,375,000 is leveraging multiple other sources, including state, federal, and private-sector funds, to cover the total development budget of \$40,690,249. This development cost is able to subsidize the provision of at least 67 deeply-affordable units attainable to residents making less than 30% of the area median income, thus serving some of Denver's most vulnerable families.
