In 2017, DEN signed contracts with HNTB Corp and Jacobs Engineering Group (Jacobs) to provide architectural and engineering design services relating to DEN's Concourse Expansion Program. In June 2020, the Jacobs Contract was amended to accommodate additional project requirements associated with Phase 2 work.

This second amendment to the Jacobs Contract, in the amount of \$3M will increase capacity to accommodate additional design work needed for the following:

- Phase 1 DS Taxiway - Additional deicing capacity
- B East Hot Water Damage Repairs

This amendment to the Jacobs Contract will increase contract capacity to accommodate the additional project requirements and meet aggressive schedules.
