The Four Mile Historic Park is managed by the Four Mile Historic Park Inc, a 501c(3) operating under a Cooperative Agreement with the City and County of Denver. This agreement stipulates that any proposed fee changes will be submitted to the DPR Manager, with the Manager's recommendation on the proposal to City Council for consideration and action.

The Four Mile Historic Park is requesting fee increases for facility rental rates and a change in the price structure to match prevailing practices in the facility rental market. The Four Mile Historic Park maintains a commitment to ensuring access for all, through SCFD free days, participation in the 5x5 program, and three free admission events per year.
