Ordinance No. 74 in the 2013 Series, which established Special Revenue Fund No. 11860, the "Metro Mortgage Assistance Plus Program" Fund, assigned 2550000 as the cost center associated with said fund. Subsequently, Ordinance No. 1501 in the 2019 Series, changed the cost center to 2500000, which is a roll-up under DOF to provide enough flexibility for management of the trust funds moving forward. This program is now being administered by the Department of Housing Stability, which was created in 2019. As such, this bill request seeks to amend the aforementioned ordinances to change the cost center from 2500000 to 0145100.

This ordinance request is submitted along with two other bill requests to move the Metro DPA program to HOST. It is also a companion ordinance to the 2021 Long Bill.
