Amends an existing contract between the Denver Office of Economic Development (OED) and Arapahoe County, Community Resource Department, A/D Works! Division regarding grant agreement HG-26659-15-60-A-8 entitled H1-B Ready- to-Work, with the Colorado grantee entity being the Technology Employment in Colorado Partnerships (TEC-P), for which OED serves as grant administrator for Denver and its regional partners, and extending the end date of the grant period by an additional six months, from September 30, 2018 to March 31, 2019, with an increase in funding from \$649,370.16 to \$751,743.60, an additional \$102,373.44. Arapahoe County's participant goal will increase from 90 to 114.
