Executive Summary with Rationale and Impact:

Detailed description of the item and why we are doing it. This can be a separate attachment. The proposed ordinance would authorize a refunding, by means of a bond exchange or redemption, of existing Series 1992F-G Airport Revenue Bonds in order to activate a Bond Reserve Requirement provision change within the Airport's General Bond Ordinance. The Bond Reserve Requirement provision was authorized by Council in 2018 however, this change can only be implemented when no Bonds issued prior to August 1, 2000 remain outstanding. The refunding of the 1992F-G bonds is necessary to satisfy the condition referenced above. The change in calculation methodology would allow for a lower Bond Reserve Requirement which would allow for release of approximately \$113.8 million from the Bond Reserve Fund to fund portion of existing CIP needs and would bring in-line the Bond Reserve Requirement with industry standards.

The terms of the 2021A-B bonds will remain the same as the 1992F-G bonds, with the exception of the change in Series designation (1992F-G to 2021A-B).

The proposed 2021A-B Bonds are not considered new money financings that would add to the Airports existing principal portfolio balance. The bonds are and will continue to be paid solely from airport revenues and are not a direct obligation of the City.
