Resolution approves the contract amendment with Riskonnect ClearSight through October 31, 2019. Total contract amount by end of Year 5 and additional 6 months will be \$1,047,626. Riskonnect ClearSight LLC, formerly Marsh ClearSight LLC provides Risk Management Information System software "STARS" used by the City's Workers' Compensation Program for the tracking of the City's workers' compensation, auto and property claims. This resolution adds \$97,800 for an additional 6 months for data conversion and testing. Contract Amendment for an additional 6 months to coincide with implementation of new system including data conversion and testing.
