This contract will authorize the acceptance of the 2018-2019 funding for Continuum of Care-Spectrum to provide tenant, sponsor, and project based rental assistance to chronically and episodically homeless single individuals. These individuals could also have co-occurring disabilities such as mental health issues and other HUD approved disabilities. The award amount is \$811,222.00 beginning July1, 2018, through June 30, 2019.
