This lease is for Southwest Airlines Co. (Southwest) to lease space in a Ground Service Equipment (GSE) Maintenance Building to support its operations at Denver International Airport (DEN). The area to be leased to Southwest is 19,374.6 sq. ft. of building space and 53,969.6 sq. ft. of ground space. Southwest will pay DEN Rates & Charges for the space. Annual rent to the City in 2020 rates is approximately \$206,000.00 annually.
