The ordinance authorizes two new licenses adopted by the state legislature in 2019. The marijuana hospitality business license allows for consumers to bring their own marijuana to consume on the premises, which may be mobile. The marijuana hospitality and sales business license allows for single serving sales of marijuana for on-premises consumption. The ordinance opts in to an exemption from the Colorado Clean Indoor Air Act for marijuana hospitality businesses, which allows for indoor smoking and vaping of marijuana. These licenses will be exclusively available to individuals who qualify as social equity applicants under the state's criteria until July 1, 2027.
