Wilson & Company will provide all necessary design and professional services for issuance of complete "For Construction" plans and specification documents for the Denver Rock Island Railroad (DRIR) Consolidation and the DRIR Maintenance Facility Relocation project. The scope of services for this contract include design of through track, storage track, at grade crossings, fencing, rail bridge structures, survey, geotech, complete maintenance facility design, drainage and water quality, and track design to maintain service to the property of McDonald Farms Enterprises. The scope also includes support for CPUC submittals, all permitting and regulatory requirements as related to the scope of work, necessary stakeholder coordination, development of probable costs for all improvements, preparation of sequencing plans to accommodate the operational switchover required by the overall National Western Center Capital Build, and construction support services.
