Resolution approves the extension of the contract with Riskonnect ClearSight through December 31, 2020. Total contract amount through 2020 will be \$1,257,626. Riskonnect ClearSight LLC, formerly Marsh ClearSight LLC provides Risk Management Information System software "STARS" used by the City’s Workers’ Compensation Program for the tracking of the City’s workers’ compensation, auto and property claims. This resolution adds \$210,000.00 for an additional 14 months for data continuation of services.
