Type and Scope of services to be performed:

This request is for a non-competitive lease amendment between the US Government General Services Administration and Denver International Airport (DEN). The US Government leases administrative space for the TSA's operation at DEN. This amendment adds a 1681 sq. ft. breakroom in the South Security Checkpoint. The additional space is added, effective June 5, 2023, to the end of the lease term, December 31, 2026. This is a revenue contract.

The rates being charged were negotiated with the Federal Government and include an Operations Cost which escalates annually based on the Consumer Price Index. The Operations Cost covers janitorial services, maintenance and utilities costs.
