Type and Scope of services to be performed:

Work to be done by a Design engineering team for professional services necessary to provide full design, specifications, cost estimates, and construction bid documents necessary for the replacement of the W. 8th Ave Bridge over the S. Platte River. Services include, but are not limited to, bridge engineering, surveying, hydraulic analysis, project management, geotechnical investigations, evaluation of environmental impacts, roadway and trail design and detours, utility coordination, and public involvement. The RFQ for this Contract stated that Professional Services during construction would eventually be requested from the selected firm.

Replace an 89-year-old bridge which has far exceeded its initial life expectancy. The bridge serves as an important transportation link to and from Interstate 25 for critical local truck access to nearby industrial uses.
