Type and Scope of services to be performed:

Original agreement includes design services for the Congress Park Pool Renovation project at 850 Josephine St, Denver, CO 80206. Design services include public participation plan, program verification & development, schematic design, design development, construction documents, and construction administration. The renovation scope includes replacing the existing outdoor pool, a new pool deck, replacement of the existing bath house, new support systems & facilities, and other necessary improvements.

Amendment to add \$90,500.00 in total capacity, 4 months to contract term and additional scope. Breakdown in capacity addition is as follows: commissioning (\$15,500.00) and additional services (\$75,000.00).

The project is now requesting to add additional components to help achieve LEED certification, such as further commissioning and additional services, to remain flexible in the evolving scope required to attain LEED certification. As with all LEED projects, until the scope is fully vetted by the design team, the exact LEED points cannot be definitively determined. Finally, and most importantly, this project includes a robust public outreach process to help define scope elements. With the public's input, scope elements are being refined and are now known, which enables us to hone in on LEED credits that are most applicable to the project, and those that can be obtained in the most cost-effective and efficient manner.
