DEN requested proposals to seek on-call, professional roustabout services for maintenance and regulatory reasons, at the DEN oil and gas wells. ATP will provide roustabout services, including labor, equipment, and associated supplies to maintain, replace, and/or install surface equipment at the oil and gas wells, plus corresponding flowline, gas lines, and tank lines. Roustabout services are required for remedial work and compliance with regulatory agencies. The service is also required to permanently plug and abandon wells as well for wells that are temporarily shut in. DEN was seeking up to two (2) on-call contracts. However, DEN only received one proposal from ATP.
