Additional work includes design development of the remaining play pods, and construction documents for the Play Loop, Community Plaza, Kiosk Building, Fitness Loop, and the remainder of the Phase 2 area. Service additions will also include cost estimating, updates to the environmental reports, irrigation design, and bidding assistance.
