Amends an intergovernmental agreement with Denver Health and Hospital Authority by adding \$58,021 for a new total of \$1,107,171 to provide early intervention services for minority AIDS initiatives for new clients and to enhance the outpatient/ambulatory health services to individuals living with HIV/AIDS in the Denver Transitional Grant Area. The City's HIV/AIDS Program receives a carryover fund annually from the Health Resources and Services Administration (HRSA) for disbursement to the subrecipients. The carryover award is unutilized funds from the previous fiscal year. As a result, a number of subrecipient based on system wide need and priority to certain specific services are selected for the additional award.

Denver Health and Hospital Authority (DHHA) was selected for the additional fund to provide Early Intervention Services for Minority AIDS Initiatives for new clients. This is a new program added because of the additional fund. The additional fund is also to enhance the Outpatient/Ambulatory Health Services to individuals living with HIV/AIDS in the Denver Transitional Grant Area (TGA). The Denver Transitional Grant Area includes Adams, Arapahoe, Broomfield, Denver, Douglas, and Jefferson counties. This is an existing program that DHHA already provides but needed more funds for better services.
