Executive Summary with Rationale and Impact:

Detailed description of the item and why we are doing it. This can be a separate attachment. This bill request is a companion ordinance to the minimum wage ordinance submitted by the Mayor's Office. It establishes a Special Trust Fund that will hold certain payments of unclaimed wages made by Denver employers to meet minimum wage requirements for their workers. These payments may be made in lieu of penalties/fines. Employer payments will be held in the Special Trust on workers' behalf for three years. If not claimed by a worker during that time, such funds will be transferred to the General Fund on a rolling basis.

Expenses in the fund will include reimbursements to workers for certain unclaimed wages as well as transfers to the General Fund of amounts that remain unclaimed. The expending authority will be the Auditor's Office. The fund number will be 56260.
