The Mayor's Office of the National Western Center proposes transferring surplus personal property acquired incidental to the development of the National Western Center to History Colorado, the Denver Museum of Nature and Science, the National Western Center Authority, the Western Stock Show Association, and other qualified organizations for the purpose of preserving the unique western history of the site, assisting in the construction and long-term operation of the National Western Center, and achieving project sustainability goals by diverting potential waste from landfills.
