#### **Executive Summary with Rationale and Impact:**

As part of the development process, fee title via a Quit Claim Deed was inadvertently conveyed to the city by SID, LLC, in connection with a required dedication. SID, LLC drafted their own Quit Claim Deed and recorded it outside of the process. The City does not accept Quit Claim Deed when acquiring land. By this resolution, the city will convey fee title via a Quit Claim Deed to the property back to SID, LLC, which will in turn convey the property back to the City via the City's Special Warranty Deed covering the identical area. There is no change in the affected real property; simply, the conveyance document is changed from Quit Claim to Special Warranty Deed.
