Amends a non-financial IGA with Regional Transportation District (RTD) for Colfax BRT to provide provisions for the construction phase of the project with no change in the contract term, Contract No. DOTI-202472685-01[202265079-01]. Among the changes are provisions to receive funds from an expected FTA Small Starts grant in the amount of \$126.9 Million. The original IGA addresses the Parties relationship during the design and preconstruction phase of the Colfax BRT project, including procurement of an owner's representative and procurement of a Construction Manager General Contractor (CMGC) firm. The parties expect to enter into a separate IGA to address maintenance and operations. No funds are being obligated at this time.
