Type and Scope of services to be performed:

The City's Broadway Station at I-25 Multimodal & Safety Improvement Project is located at the Broadway and Interstate 25 Interchange in Denver, Colorado. This project modifies the S. Broadway/I-25 interchange through the construction of a new southbound Interstate 25 on-ramp from the Broadway/ Ohio Intersection and through the reconstruction of the local street network in the vicinity of the interchange, which includes Broadway, Lincoln, Kentucky, Ohio and Exposition.

Other elements of the project include the construction of paved parking at the RTD I-25/ Broadway Station, installation of new or modified traffic signals, installation of new street lighting and storm sewer system improvements.

The goal of the project is to create a network that provides safe and efficient mobility for all transportation modes (pedestrian, bicycle, transit, and automobile); promote transit-oriented development; and to accommodate the existing, future and planned developments along the South Broadway corridor.
