The proposed change amends the Classification and Pay Plan by changing the pay grade and range for City Council Aide and City Council Aide Senior.

Denver City Council requested that the Office of Human Resources conduct a study to review the pay grades of the City Council Aide classification series to ensure competitive pay ranges. As a result, it is recommended to raise the pay grades for the City Council Aide and City Council Aide Senior classifications by one grade.

Career Service Rule 7-37 Effective Dates, Section A: If it is determined that changes to the classification and pay plan are necessary, the effective date of any resulting changes to the classification and pay plan shall be the beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto. Provisional classifications resulting

from changes to the classification and pay plan may be used upon approval by the OHR Executive Director or Board but use for longer than six months is contingent upon City Council approval.
