- A. To support and engage eligible participants to develop strategies that address individual and family needs, DHS will work jointly with Contractor to provide the following:
  - 1. In depth assessment, family counseling, and work support programs associated with the implementation and operation of the TANF Program for households. These households may have limited marketable vocational skills, commitment and/or work experience.
    - a. It is anticipated that long term family income may be through other source such as SSI/SSDI, or employment earnings.
  - 2. Services include but are not limited to intensive case management, life and work skills classes, career exploration, Adult Basic Education (ABE), General Educational Development (GED)/High School Equivalency (HSE) attainment, and ongoing post-job placement support.
    - a. Households may not initially meet full participation within TANF due to barriers that are being resolved.
    - b. It is anticipated that long term family income will be through employment earnings.
  - 3. Services include but are not limited to intensive case management, life and work skills classes, career exploration, parent classes, connection to employment supports as well as services and resources to family stabilization.
