DHS requests authorization to approve a third amendment to the contract with Maple Star Colorado to add \$189,000 for a new contract total of \$667,000 and to extend the term by twelve (12) months for a new end date of 6/30/2023, through contract control number SOCSV-2022-63346-03 Jaggaer, to ensure that home studies are performed by State-trained and State-certified social workers, and to also ensure that children’s wellbeing and safety are met while in out-of-home care by assisting in face-to-face contact visits as needed.

- Employ SAFE Supervisors to review home studies according to SAFE requirements.
