This ordinance request seeks approval to establish a new non-lapsing "Excise Tax Reserve" capital special revenue fund (Fund 38421) under the Department of Finance. The source of revenue to this fund will be excise tax overperformance as part of the 2C (Series 2016) dedicated excise tax flow of funds. The fund will serve as a reserve for future capital projects and debt issuances at the National Western Center and the Colorado Convention Center. Revenues to this fund will be budgeted in arrears annually based on audited financials.
