Bayaud Enterprises, Inc.'s Denver Day Works program provides same-day work experience to individuals in the City and County of Denver who are homeless and not actively engaged in day program services. Bayaud will provide outreach and recruitment to at least 200 homeless individuals to participate in the program.

Bayaud coordinates and supervises work experiences at approved private, city, or other public sites for participants. Bayaud will also provide benefit navigation, behavioral health referrals, job readiness assessments, individualized employment plans and meals to participants during work experience activities.
