Executive Summary with Rationale and Impact:

Section 29-11-102 of the Colorado Revised Statutes authorizes the City to adjust the surcharge for Enhanced 911 ("E-911") services as needed for the protection and preservation of the public health and as necessary for the acquisition of equipment, provision of initial services, and operation of the emergency telephone service. The City's current monthly E911 surcharge is \$0.70 per telephone line in the City and County of Denver. In order to meet the City's need for effective E911 infrastructure and services, the City intends to increase the monthly surcharge to \$1.20. However, any increase in the E911 surcharge to a monthly amount higher than \$0.70 per telephone line requires approval by the Colorado Public Utilities Commission ("PUC"). PUC rules require City Council to authorize the application for the surcharge increase before submitting the application. This resolution serves that purpose.
