This Third Amendatory Agreement is between Denver Human Services and Point b(e) Strategies, wherein Point b(e) Strategies will manage a \$600,000 mini-project fund that reimburses I/DD service providers and small Denver businesses for projects that combat isolation, loneliness, and disengagement from critical services for people with I/DD in Denver as a result of the COVID-19 pandemic. Reimbursement for individual projects through the fund is limited to a maximum of \$20,000 per project, allowing for at least 30 potential projects to be funded throughout the contract term.
