The Federal Highway Safety Improvement Program (HSIP) funds' HSIP CCD 2018 Pkg 2 project is to construct six (5) new traffic signals (Federal & 38th: \$500,000; Federal & Kentucky: \$500,000; Federal & Mississippi: \$500,000; Federal & Jewell: \$400,000; Colorado Blvd & MLK: \$1,500,000). No matching will be required. Note: Packet 1 and Packet 3 have already gone through Council, this package 2 was temporarily held back and is now ready to proceed.
