The Denver Day Works program is a supported work program designed to provide a low- to no-barrier work experience for people throughout the city who are experiencing homelessness, while also connecting participants to supportive services such as food, shelter, and other necessities.

Bayaud coordinates and supervises work experiences at approved private, city, or other public sites for participants. Bayaud will also provide benefit navigation, behavioral health referrals, job readiness assessments, individualized employment plans and meals to participants during work experience activities.

Bayaud will provide outreach and recruitment to at least 220 homeless individuals to participate in the program.
