The 2022 Annual Appropriation Ordinance, Ordinance No. 1284, Series of 2021, authorized the 2022 spending allocation in the Denver Arts and Venues Special Revenue Fund, 15815. This ordinance was intended to authorize the purchase of two video display boards in Section 9, which identifies capital equipment in Special Revenue Funds that requires City Council authorization, per the Denver Revised Municipal Code, since it will exceed the \$50,000 threshold. However, this item was excluded because the budget entry was entered in non-capital equipment account code. This bill request authorizes the purchase of the equipment as a corrective action.
