(SITA) to continue to provide 24x7x365 software maintenance and support for Denver International Airport's (DEN) Flight Information Display Systems (FIDS). This contract will provide coverage for three (3) years. Without a support contract DEN's FIDS will not receive regular software updates, nor receive support in the event of an emergency. In addition to the annual support and maintenance, SITA will assist with delivering working solutions for the Concourse Expansion, Concourse Retrofit, and Great Hall Redevelopment projects.
