**Type and Scope of services to be performed:**

Touchstone IQ LLC provides help desk and compliance services for the Energize Denver benchmarking and performance requirements, assisting approximately 3,000 buildings in the city. The contract was amended to add a year while it was still under the \$500,000 threshold, and therefore it did not require council approval at that time. The services provided are help center management, content and system development for the benchmarking program and new performance policy, and a direct technical assistance program serving under-resourced buildings.

Touchstone IQ LLC provides help desk and compliance services for the Energize Denver benchmarking and performance requirements, assisting approximately 3,000 buildings in the city. The amendment extends the scope of work for an additional year now that the final rules for the program were adopted on November 17, 2022. The services provided are help center management, content and system development for the new performance policy, and a direct technical assistance program serving under-resourced buildings.
